

Guide for Authors

Journal of Gono Bishwabidyalay is a double-blind peer-reviewed international journal published by Gono Bishwabidyalay that provides rapid publication of articles in different academic fields. It invites articles with original and innovative research.

Submission

Authors should kindly note that submission of a manuscript implies that the content has not been published or submitted for publication elsewhere except as a brief abstract in the proceedings of a scientific meeting or symposium.

Aims and Scope

Journal of Gono Bishwabidyalay is a peer-reviewed journal for rapid dissemination of research in all areas of science, health and biological science, information science, social science, arts and humanities as well as interdisciplinary research. The journal intends to publish Original/ Regular Papers, Short Communications, Popular Article, Review Articles, and Comprehensive Reviews.

Data Protection

The publication and the publisher recognize the importance of protecting the personal information (name, email address, affiliation, and other personal details) and manuscript information collected from the authors and have practices in place to ensure that steps are taken to maintain the security, integrity, and privacy of the data collected and processed.

Manuscript Preparation

The manuscript should be submitted in one file: figures, tables and images should be inserted into the main text file.

The title page of the manuscript should be submitted separately and will include the Title, Author(s) name(s), and detailed affiliations.

The main body of the article will include the Title (without author(s) name(s) and affiliations), Abstract, Key-words followed by Introduction, Main text (Materials and Methods, Results and Discussion, Conclusion), and other sections including declaration (if any) and references accordingly. All pages must be numbered at the center of the bottom margin.

The manuscript must be written in either Bengali (in 'Sutonny MJ' font with 13 font size) or English (in 'Times New Roman' font with 12 font size). Line space would be 1.5 and margin will be 1 inch/2.54 cm on all sides). All the headings and subheadings will be in 14 font size, bold.

The text file should be presented in the following format and order:

- A short informative title that contains the major keywords. The title should not contain abbreviations; it should be 16 font size, bold.
- The full name(s) of the author(s); (10 font size, Italic)
- The author(s) institutional affiliations where the work was conducted (10 font size, Italic), with a footnote for the author(s) present address if different from where the work was conducted.

All other texts including

Abstract: Short informative abstract with 250-350 words in 12-point italic font containing the key ideas/findings. The abstract should contain key findings, methodologies, and conclusions without any subheading.

Keywords: 4 to 6 relevant keywords

Corresponding author: Just after the Keywords corresponding author's email address and communication details should be given (in 10 font size, underlined and italic).

Main text: Introduction, Materials and Methods, Results and Discussion, Conclusion should be written according to above-stated format. the Maximum word count for the manuscript is 5000 words.

References: Reference style should be 'Harvard Style' or 'Vancouver' for articles from science, health and biological sciences, information science and it would be 'APA' (American Psychology Association) 7th edition style for articles from Social Science and Humanities field.

Authorship

There must be a direct contribution in the work to be eligible for listing a name as an author. Author's contributions should be specified separately during submission (see the author contribution template). A separate list should be provided detailing all the authors' information and a short biography of the corresponding author and the first author/authors.

Acknowledgments

Contributions from anyone who does not meet the criteria for authorship should be listed, with permission from the contributor, in an Acknowledgments section. Financial and material support should also be mentioned. Thanks to anonymous reviewers are not appropriate.

Conflict of Interest Statement

Authors will be asked to provide a conflict-of-interest statement during the submission process. Submitting authors should ensure that they liaise with all co-authors to confirm agreement with the final statement.

Ethical Statements

An Ethical Statement section is required between the main text and reference list for all submissions. Conflict of interest, ethical review, and informed consent must be addressed. Use the heading "Ethical Statements" for this section. An example is given below.

Conflict of Interest

"The authors declare that they do not have any conflict of interest in terms of funding and data dissemination."

Ethical Review

"This study does not involve any human or animal testing" or "This study was approved by the Institutional Review Board of XYZ University (with approval number)".

Informed Consent

Written informed consent was obtained from all study participants.
